## Pacific Alliance Bank Announces Period Ending December 31, 2018 Results

Pacific Alliance Bank's (PFBN) unaudited operating results for the period ending December 31, 2018 are as follows:

- ➤ The Bank posted a net income after income taxes of \$3,511,000 or \$1.12 per share for the 12-months ended December 31, 2018, compared with a net income of \$1,898,000 or \$0.60 per share for the same period in 2017. The positive result in the current year was partially attributed to the passage of the 2018 tax reform bill.
- Total Assets increased by \$5.17 million to \$267.60 million, a 1.97% increase from \$262.44 million at December 31, 2017.
- ➤ Gross Loans outstanding increased by \$6.58 million to \$209.79 million, a 3.24% increase from \$203.21 million at December 31, 2017.
- Total Deposits decreased by \$864,000 to \$225.63 million, a -0.38% decrease from \$226.49 million at December 31, 2017.
- ➤ Loan loss provision in the amount of \$48,000 was provided in the period ended December 31, 2018. Allowance for loan losses to total gross loans was at 1.81% at December 31, 2018.
- There were no impaired loans on the SBA loan unguaranteed portion at December 31, 2018.
- ➤ The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines, with common equity tier 1 capital ratio of 16.41%, tier 1 capital ratio of 16.41%, total capital ratio of 17.67% and tier 1 leverage ratio of 13.53%.
- The Bank's ROA as of December 31, 2018 was 1.29% and ROE was 10.07%. For the same period in 2017, ROA was 0.72% and ROE was 5.91%.
