Pacific Alliance Bank Announces Fourth Quarter 2019 Operating Results

ROSEMEAD, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending December 31, 2019 are as follows:

- The Bank reported after tax net income of \$2.32 million or \$0.74 per share for the 12-months ended December 31, 2019, compared with a net income of \$3.51 million or \$1.12 per share for the same period in 2018. The decrease year over year was primarily attributed to the declining interest rate environment in the current year.
- Total assets increased by \$1.52 million to \$269.12 million, a 0.57% increase from \$267.60 million at December 31, 2018.
- Gross loans outstanding increased by \$3.99 million to \$213.78 million, a 1.90% increase from \$209.79 million at December 31, 2018.
- Total deposits decreased by \$4.25 million to \$221.38 million, a 1.88% decrease from \$225.63 million at December 31, 2018.
- There was a reversal of \$400,000 in provision for loan losses which reduced the allowance for loan losses to \$3.40 million at December 31, 2019. The allowance for loan losses to total gross loans was 1.59% at December 31, 2019.
- There were no impaired loans on the SBA loan unguaranteed portion at December 31, 2019.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 16.82%, tier 1 capital ratio of 16.82%, total capital ratio of 18.07% and tier 1 leverage ratio of 14.18%.
- The Bank's ROA as of December 31, 2019 was 0.83% and ROE was 6.11%. For the same period in 2018, ROA and ROE were 1.29% and 10.07%, respectively.
