Pacific Alliance Bank Announces Second Quarter 2021 Operating Results

ROSEMEAD, CALIFORNIA – Pacific Alliance Bank (OTC: PFBN) unaudited operating results at and for the period ending June 30, 2021 are as follows:

- The Bank reported after tax net income of \$1.81 million or \$0.58 per share for the 6-months ended June 30, 2021, compared with a net income of \$1.05 million or \$0.33 per share for the same period in 2020. The increase year over year was primarily attributed to the strong growth in deposits and loans in the current year.
- Total assets increased by \$21.27 million to \$348.36 million, a 6.50% increase from \$327.09 million at June 30, 2020.
- Gross loans outstanding increased by \$34.70 million to \$274.52 million, a 14.47% increase from \$239.82 million at June 30, 2020.
- Total deposits increased by \$28.75 million to \$294.95 million, a 10.80% increase from \$266.20 million at June 30, 2020.
- There was addition in provision for loan losses of \$140,000 which increased the allowance for loan losses to \$4.03 million at June 30, 2021. The allowance for loan losses to total gross loans was 1.47% at June 30, 2021.
- There were no impaired loans on the SBA loan unguaranteed portion at June 30, 2021.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 14.21%, tier 1 capital ratio of 14.21%, total capital ratio of 15.47%, tier 1 leverage ratio of 11.93% and community bank leverage ratio (CBLR) of 11.93%.
- The Bank's ROA as of June 30, 2021 was 1.02% and ROE was 8.71%. For the same period in 2020, ROA and ROE were 0.73% and 5.33%, respectively.
