Pacific Alliance Bank Announces Third Quarter 2020 Operating Results

ROSEMEAD, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending September 30, 2020 are as follows:

- The Bank reported after tax net income of \$1.57 million or \$0.50 per share for the 9-months ended September 30, 2020, compared with a net income of \$1.82 million or \$0.58 per share for the same period in 2019. The decrease year over year was primarily attributed to the declining interest rate environment in the current year.
- Total assets increased by \$81.91 million to \$358.67 million, a 29.60% increase from \$276.76 million at September 30, 2019.
- Gross loans outstanding increased by \$61.59 million to \$258.94 million, a 31.21% increase from \$197.37 million at September 30, 2019.
- Total deposits increased by \$66.49 million to \$296.22 million, a 28.94% increase from \$229.73 million at September 30, 2019.
- There was addition in provision for loan losses of \$434,000 which increased the allowance for loan losses to \$3.84 million at September 30, 2020. The allowance for loan losses to total gross loans was 1.48% at September 30, 2020.
- There were no impaired loans on the SBA loan unguaranteed portion at September 30, 2020.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 14.34%, tier 1 capital ratio of 14.34%, total capital ratio of 15.60%, tier 1 leverage ratio of 11.56% and community bank leverage ratio (CBLR) of 11.56%.
- The Bank's ROA as of September 30, 2020 was 0.68% and ROE was 5.23%. For the same period in 2019, ROA and ROE were 0.87% and 6.48%, respectively.
