Pacific Alliance Bank Announces Second Quarter 2022 Operating Results

SAN GABRIEL, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending June 30, 2022 are as follows:

- The Bank reported after tax net income of \$2.58 million or \$0.82 per share for the 6-months ended June 30, 2022, compared with a net income of \$1.81 million or \$0.58 per share for the same period in 2021.
- Total assets decreased by \$119,000 to \$348.24 million, a 0.03% decrease from \$348.36 million at June 30, 2021.
- Gross loans outstanding decreased by \$6.07 million to \$268.45 million, a 2.21% decrease from \$274.52 million at June 30, 2021.
- Total deposits decreased by \$8.90 million to \$286.05 million, a 3.02% decrease from \$294.95 million at June 30, 2021.
- There was no addition in provision for loan losses. The allowance for loan losses was \$4.19 million at June 30, 2022. The allowance for loan losses to total gross loans was 1.56% at the end of second quarter of 2022.
- There was one impaired loan on the SBA loan unguaranteed portion and one mortgage loan on non-accrual status at June 30, 2022, which totaled \$416,000.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 15.77%, tier 1 capital ratio of 15.77%, total capital ratio of 17.02%, tier 1 leverage ratio of 13.29% and community bank leverage ratio (CBLR) of 13.29%.
- As of June 30, 2022, the Bank's ROA was 1.42% and ROE was 11.47%. For the same period in 2021, ROA and ROE were 1.02% and 8.71%, respectively.
