## Pacific Alliance Bank Announces Third Quarter 2022 Operating Results

SAN GABRIEL, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending September 30, 2022 are as follows:

- The Bank reported after tax net income of \$3.91 million or \$1.23 per share for the 9months ended September 30, 2022, compared with a net income of \$3.27 million or \$1.04 per share for the same period in 2021.
- Total assets decreased by \$13.94 million to \$358.98 million, a 3.74% decrease from \$372.92 million at September 30, 2021.
- Gross loans outstanding increased by \$14.98 million to \$299.37 million, a 5.27% increase from \$284.39 million at September 30, 2021.
- Total deposits decreased by \$34.25 million to \$283.21 million, a 10.79% decrease from \$317.46 million at September 30, 2021.
- There was an addition in provision for loan losses of \$14,000 which increased the allowance for loan losses to \$4.20 million at September 30, 2022. The allowance for loan losses to total gross loans was 1.40% at September 30, 2022.
- There was one impaired loan on the SBA loan unguaranteed portion and one mortgage loan on non-accrual status at September 30, 2022, which totaled \$410,000.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 14.97%, tier 1 capital ratio of 16.22%, tier 1 leverage ratio of 13.94% and community bank leverage ratio (CBLR) of 13.94%.
- The Bank's ROA as of September 30, 2022 was 1.45% and ROE was 11.46%. For the same period in 2021, ROA and ROE were 1.23% and 10.33%, respectively.
