Pacific Alliance Bank Announces Fourth Quarter 2022 Operating Results

SAN GABRIEL, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending December 31, 2022 are as follows:

- The Bank reported after tax net income of \$5.13 million or \$1.62 per share for the 12-months ended December 31, 2022, compared with a net income of \$4.83 million or \$1.54 per share for the same period in 2021.
- Total assets increased by \$18.50 million to \$390.79 million, a 4.97% increase from \$372.29 million at December 31, 2021.
- Gross loans outstanding increased by \$27.51 million to \$305.08 million, a 9.91% increase from \$277.57 million at December 31, 2021.
- Total deposits decreased by \$1.36 million to \$312.55 million, a 0.43% decrease from \$313.91 million at December 31, 2021.
- There was an addition of \$176,000 in provision for loan losses which increased the allowance for loan losses to \$4.36 million at December 31, 2022. The allowance for loan losses to total gross loans was 1.43% at December 31, 2022.
- The Bank continues to be categorized as “well-capitalized” under the regulatory guidelines with common equity tier 1 capital ratio of 15.09%, tier 1 capital ratio of 15.09%, total capital ratio of 16.34%, tier 1 leverage ratio of 13.35% and community bank leverage ratio (CBLR) of 13.35%.
- The Bank’s ROA as of December 31, 2022 was 1.41% and ROE was 11.18%. For the same period in 2021, ROA and ROE were 1.33% and 11.25%, respectively.
