Pacific Alliance Bank Announces Third Quarter 2023 Operating Results

SAN GABRIEL, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** unaudited operating results at and for the period ending September 30, 2023 are as follows:

- The Bank reported after tax net income of \$2.68 million or \$0.83 per share for the 9-months ended September 30, 2023, compared with a net income of \$3.91 million or \$1.23 per share for the same period in 2022.
- Total assets increased by \$26.01 million to \$384.99 million, a 7.25% increase from \$358.98 million at September 30, 2022.
- Gross loans outstanding decreased by \$11.14 million to \$288.23 million, a 3.72% decrease from \$299.37 million at September 30, 2022.
- Total deposits increased by \$18.39 million to \$301.59 million, a 6.49% increase from \$283.21 million at September 30, 2022.
- There was no addition in provision for loan losses. The allowance for loan losses was \$4.36 million at September 30, 2023. The allowance for loan losses to total gross loans was 1.51% at September 30, 2023.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines with common equity tier 1 capital ratio of 16.94%, tier 1 capital ratio of 16.94%, total capital ratio of 18.19%, tier 1 leverage ratio of 13.75% and community bank leverage ratio (CBLR) of 13.75%.
- The Bank's ROA as of September 30, 2023 was 0.91% and ROE was 7.28%. For the same period in 2022, ROA and ROE were 1.45% and 11.46%, respectively.
